HISTORY OF THE FOUNDATION

1985. The Texas Speech-Language-Hearing Foundation (TSHF) was established by TSHA with the first Board of Directors composed of TSHA officers: Richard Stream, Mary Lovey Wood, Joseph Helmick, and Robbin Parish. The creation of a nonprofit foundation appeared necessary because Braniff Women's Auxiliary had endowed a scholarship fund to support speech-language-pathology students enrolled in any of four North Texas universities. Between 1985 and 1992 three \$500 scholarships were awarded.

1992. Anne Mauzy was appointed by Sandy Friel-Patti (TSHA president) to reorganize the TSHF. The first Board of Directors consisted of Anne Mauzy, President, Tina Bangs, Vice-President; and Larry Higdon, Publicity. Carolyn Wells was soon added to the Board. The Foundation was incorporated as a 501 (c)(3) charitable organization. Cash in hand was \$19,309. When Anne Mauzy left the presidency three years, later the cash in hand plus total pledges equaled \$100,000. The current program of activity was in place.

Educational Programs

The Oscar Mauzy Leadership Conference conference is a joint effort between the Texas Speech-Language-Hearing Foundation and the TSHA Executive Board, and serves as a training opportunity for leadership growth and development for both organizations. The conference is named for Oscar Mauzy (1926-2000), a Texas state senator from Dallas (1966-1986) and former justice of the Texas Supreme Court (1987-1992). He was wellknown to speech-language pathologists and audiologists across the state for his dedication to our causes, and also for his good fortune in marrying Anne Rogers Mauzy, a speech-language pathologist, who is now Director Emerita of the Texas Speech-Language-Hearing Foundation. This year, Texas Speech-Language-Hearing Foundation (TSHF) board member Ann Higdon, worked with TSHA co-chair Donise Pearson to develop the 2015 Oscar Mauzy Leadership Conference, titled "Leading with Style". The conference was held March 21, in conjunction with the TSHA annual convention. The conference included a panel of Foundation Fellows (Jennifer Watson, Cherry Wright, Dee Kirby, Shannon Butkus, Denise Barringer, Margarita Limon-Ordonez) who talked about leading in different professional organizations (ASHA, TSHA, TSHF) and practice sites (private practice, medical settings, schools). ONGOING GOALS OF THE FOUNDATION

- 1. Facilitate all Scholarship Funds reaching the \$20,000 level. As of January, 2015, all scholarships were funded at the \$20,000 level or greater.
- 2. Maintain ongoing communication with Foundation Donors and Fellows. The TSH Foundation Recording Secretary sends each donor a handwritten note thanking them for their contribution or pledge payment.
- Strengthen collaboration between TSHF and TSHA. Articles were included in each issue of the Communicologist during the report period. Reminders concerning the due dates for awards were announced on the TSHF and TSHA Facebook pages. The President attended all of the TSHA Executive Board meetings and submitted an Annual Report to the TSHA.
- 4. Encourage pledged Fellows to complete their pledge commitments. Individual fellows were contacted to encourage them to fulfill their current pledge or to pledge at the next level of giving as they completed their pledge commitment.
- 5. Conduct formal reviews of the financial records of the TSH Foundation on a regular schedule.
- 6. Nurture close relationships with Fund Sponsors. In November 2014, the President sent each fund sponsor a letter indicating the amount available for the 2015 award and a brief financial report. The letter also included a request to consider adding to the principal of the fund.

- 7. Sponsor educational programs designed to recognize current professional leaders and provide mentors for future leaders. In 2015, the TSHF partnered with TSHA to host the Oscar Mauzy Leadership Conference during the annual TSHA convention in San Antonio.
- 8. Develop and implement a Fund Management Policy for spending and investment to provide guidance to the TSH Foundation Board and Finance Committee. The Fund Management Policy was developed in Fall 2011 and has been implemented in subsequent years.
