HISTORY OF THE FOUNDATION

1985.The Texas Speech-Language-Hearing Foundation (TSHF) was established by TSHA with the first Board of Directors composed of TSHA officers: Richard Stream, Mary Lovey Wood, Joseph Helmick, and Robbin Parish. The creation of a nonprofit foundation appeared necessary because Braniff Women's Auxiliary had endowed a scholarship fund to support speech-language-pathology students enrolled in any of four North Texas universities. Between 1985 and 1992 three \$500 scholarships were awarded.

1992. Anne Mauzy was appointed by Sandy Friel-Patti (TSHA president) to re-organize the TSHF. The first Board of Directors consisted of Anne Mauzy, President, Tina Bangs, Vice-President; and Larry Higdon, Publicity. Carolyn Wells was soon added to the Board. The Foundation was incorporated as a 501 (c)(3) charitable organization. Cash in hand was \$19,309. When Anne Mauzy left the presidency three years, later the cash in hand plus total pledges equaled \$100,000. The current program of activity was in place.

Educational Programs

The Oscar Mauzy Leadership Conference conference is a joint effort between the Texas Speech-Language-Hearing Foundation and the TSHA Executive Board, and serves as a training opportunity for leadership growth and development for both organizations. The conference is named for Oscar Mauzy (1926-2000), a Texas state senator from Dallas (1966-1986) and former justice of the Texas Supreme Court (1987-1992). He was well-known to speech-language pathologists and audiologists across the state for his dedication to our causes, and also for his good fortune in marrying Anne Rogers Mauzy, a speech-language pathologist, who is now Director Emerita of the Texas Speech-Language-Hearing Foundation. This year, Texas Speech-Language-Hearing Foundation (TSHF) board member Ann Higdon, worked with TSHA co-chair Donise Pearson to develop the 2016 Oscar Mauzy Leadership Conference which was held at the 2016 TSHA Annual Convention held in Fort Worth on March 12. A key purpose of the Conference was to encourage the approximately 75 attendees to apply for the new TSHA Leadership Academy. After welcomes from the TSHA and TSHF presidents, Judy Rudebusch and Jennifer Watson, presentations and small group discussions explored a variety of leadership topics. These topics included history of the TSHA and TSHF, TSHA governance structure and volunteer opportunities, an overview of the TSHA Leadership Academy, and information on what it means to be a leader, the Transformational Leadership Model and personal accountability as a leader. Opportunities to network with emerging and established leaders in the professions were provided. The presenters were Sherry Sancibrian, Donise Pearson, Lauren Mathews, and Ann Higdon.
